Accepting a job at FCHC will also qualify you to apply for Loan Repayment assistance programs for example:

<u>National Health Service Corps Loan Repayment Program</u> for primary care medical, dental, and mental and behavioral health clinicians. The mission of the National Health Service Corps is to provide primary care to medically underserved populations in the U.S. As these needs change, it is possible that more clinicians may be added to the eligibility list. Currently, only fully-trained, licensed health professionals in the following disciplines are eligible to apply to the National Health Services Corps Loan Repayment Program.

- Primary health care clinicians: physicians (MD or DO), physician assistants, nurse practitioners, certified nurse-midwives
- Dental health care clinicians: general practice and pediatric dentists, registered dental hygienists
- Behavioral and mental health care clinicians: psychiatrists, health service psychologists, licensed clinical social workers, psychiatric nurse specialists, marriage and family therapists, and licensed professional counselors.

Service Commitment: 2 years Tax liability: Taxable free Repayment: Up to \$50,000

<u>Students to Service Loan Repayment Program</u>- Medical students (MD or DO) may earn up to \$120,000 in their final year of school through the Students to Students to Service Loan Repayment Program (S2S LRP). Students must commit to serving either 3 years full-time or 6 years part-time at an NHSC-approved site with a Health Professional Shortage Area (HPSA) score of 14 or higher.

<u>State Loan Repayment Program</u>- The SLRP requires matching funds from the state applicant and administration of the program by a state agency. States must agree to make available (directly or through donations from public or private entities) non-Federal contributions in cash toward SLRP contracts.

Service Commitment: Minimum 2-year service commitment additional 1 year of service for each year of additional support States may require longer minimum service commitments (more than 2 years) or negotiate individual contracts with providers for different service commitment periods (e.g., 2 years for physicians, 3 years for dentists, 4 years for physician assistants) to meet community needs.

\*\*SLRP participants are now also eligible for the part-time service option that is available through the national Health Service corps.

Tax liability: Taxable free Repayment: up to \$105,000
